





## OG SØLVET GÅR TIL... FIFA MIDT I FODBOLDENS STØRSTE SKANDALE...





### Some of the key findings:

- Only four federations (11%) have a nominations committee in place that performs integrity and professional checks. In only one federation, candidates are obliged to provide their manifesto.
- A minority of 12 federations (35%) publishes externally audited annual financial reports on its website. And only six federations (17%) publish annual general activity reports on their websites that include information on assets, accounts, revenue, sponsoring, and events.
- None of the federations publish reports on remuneration, including per diem payments and bonuses, of its board members and senior officials.





## Some of the key findings:

- A minority of six (17%) federations have clear conflict of interest rules. Seven (20%) federations do not have conflict of interest rules in place at all.
- In none of the federations, the selection of host candidates for major events takes place according to a transparent and objective process, in which bidding dossiers are reviewed independently and assigned a score on the basis of pre-established criteria.
- 12 federations (34%) do not have an ethics committee in place. In only five federations (14%) the ethics committee is independent from the governing body and has the power to initiate proceedings on its own initiative.





Some of the key findings:

- In only 23 federations (66%), elections take place according to clear and objective procedures and secret ballots are used.
- Only 11 federations (31%) have some form of limitation of terms for elected leaders in place.

The 35 federations are different in size and function, and they cannot all be expected to meet good governance criteria perfectly or to have the same structure or level of organisation. However, the federations generally get weak or moderate scores in most areas and end up with an average score of only 45% measured against the report's 36 governance indicators.


### Why the current scandals are far from the only reason for the need of reform:

- A lack of true commitment to the grassroots and participants
- A lack of will and ability to engage with other stakeholders than clubs and federations
- A lack of representation of youth and women
- A habit of seeking legitimacy and funding from politicians and not from members/customers
- A lack of ability to engage with new trends and new life style patterns in a system of monopolies
- A lack of innovation, efficiency, and creativity that goes with flawed internal structures

This is the perfect environment for new, innovative, communication-minded, and committed entrepreneurs who are committed to their product and their case, and dependant on their members/customers (just like some governing bodies used to be 100 years ago)!







